## ***Table 2: Disposal Site Registry: Statutory Requirements***

---

(2) The disposal site registry shall rank sites in priority for State remedial action, and include the following information with regard to each site:

- (i) A general description of the site, including its location, acreage, adjacent waterways, and estimates of the identity and the quantity of any controlled hazardous substance present;
- (ii) An assessment by the Department of any threat to public health or natural resources posed by the site;
- (iii) The status of any removal, restoration, or other remedial actions in progress or recommended by the Department;
- (iv) An assessment of the relative priority of the need for removal, restoration, or other remedial action at each site; and
- (v) A proposed time frame for site investigation and any necessary remedial action.”

## **Table 3: Proposed Timeline for Combining SML and SNML**

May 2012	Convene internal meeting with the OAG regarding State Master List.
June 2012	Prepare a draft proposed strategy for combining two lists, and establish stakeholder work group to discuss issues associated with creating single list.
August 30, 2012	Although concerned about potential stigma associated with placing a site on a list that includes National Priority List sites, the stakeholders stated that they were not as concerned with placing sites on a list entitled “Brownfield Master Inventory”. Based on this input, MDE has revised the strategy for incorporating sites into a single list.
September 2012	Revise proposed strategy. Based on comments from stakeholders at August 30, 2012 meeting, LRP will combine all SML, NML, VCP, FUDS, non-NPL Federal Facilities and Brownfield Assessment sites into a single list. The sites will be identified by a single MD-#### number within the LRP GIS website database (currently under revision).
January 2013	Complete implementation of integrating all sites into single list and posting on website.

The program has received one for Calvert TS, and has commented on it, but are still waiting for the Peninsula manual. Calvert TS had compliance issues. Counsel has advised we may want to hold off permit renewals until violations are addressed at a facility. In this case the compliance issues have been resolved, but we need the updated manual to reflect the changes in procedures that were required. Compliance with the finalized operational manual, once approved, should resolve these issues.*
